QUALIFICATION, EXPERIENCE AND AGE LIMIT FOR INITIAL APPOINTMENT

4. On the closing date for receipt of applications fixed in the relevant advertisement a candidate must possess the educational qualification and experience and must be within the age limit as mentioned against the post concerned in the schedule in the notification:

Provided that the maximum age limits will be relaxed by 3 years in the case a candidate belongs to schedule cost Buddhist community, recognized tribes of Gilgit-Baltistan in accordance with the instructions issued by the Establishment Division:

Provided further that the maximum age limits may be relaxed by not more than 10 years in respect of government servant who have completed at least 2 years continuous services on closing date of the advertisement and only up to the age of 55 years, if applicable.

QUALIFICATIONS/CONDITIONS FOR APPOINTMENT BY TRANSFER.

5. Appointment by transfer shall be made from amongst the persons holding appointment under the Government on regular basis in the

same basic pay scale or equivalent to or identical with the post to be figure provided the person concerned possesses the qualification/experience present for initial appointment or promotion. All the staff of sub-ordinate offices transferable within the same courts.

PROBATION

6. Persons appointed by promotion, initial appointment or be transfer shall be on probation for a period of one year. This period may be necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of Section-5 of GB Civil Servants Act, 2011.

<u>OUALIFICATIONS, EXPERIENCE AND</u> AGE LIMITS FOR INITIAL APPOINTMENT

- 4. A candidate must possess the educational qualifications and experience and must be within the age limit as mentioned against the posts concerned in the Schedule to this Notification provided that:—
 - (i) "Experience" means, the experience gained in a regular full-time paid job after obtaining the required qualifications;
 - (ii) the period spent by a candidate in obtaining degree of M.Phil or Ph.D in the relevant field shall be treated as practical experience up to a maximum period of two and four years, respectively, for the purpose of initial appointment, provided that:
 - (a) a candidate who has obtained the degree of M.Phil or Ph.D during service shall not be entitled to a double benefit of counting the said period as service towards experience prescribed for the post; and
 - (b) This concession shall not be available for the posts for which the prescribed qualifications is M.Phil/Ph.D.
 - (iii) the maximum age limit shall be relaxed in respect of the candidates specified and to the extent indicated in the Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993 as amended from time to time; and
 - (iv) eligibility of candidates shall be reckoned, as on the closing date fixed for submission of application in accordance with these Recruitment Rules and the Instructions issued by Federal Government and Federal Public Services Commission from time to time.

APPOINTMENT BY TRANSFER

 Appointment by transfer shall be made by selection from amongst the persons holding appointment on a regular basis under the Federal Government/Gilgit-Baltistan Government, in the same basic pay scale in which



the post to be filled exists, provided that the person concerned possesses the qualifications and experience prescribed for initial appointment to the post concerned.

PROBATION

- 6. Persons appointed by promotion or initial appointment or transfer shall be on probation in accordance with the provisions of Section 6 of Civil Servant Act, 1973, read with Rule-21 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.
- 7. This Notification issues with the approval of the Governor, Gilgit Baltistan vide their letter bearing No. G.Sectt-Admn-2(1)/2013, dated 13th February, 2014 and with the concurrence of Federal Public Service Commission vide its letter No. F.12-06/2014-RR, dated 01-04-2014.
